I AGREE TO THE FOLLOWING PROVISIONS WHEN ADOPTING FROM P.A.W.S.:

1. ___ I agree to make the adopted animal a part of the family. The animal will not be kept on a chain, live as an outside only animal or be given to a kill-shelter.
2. ___ I agree to keep the adopted animal under control. A secure fenced area will be provided for dogs, including shelter from the elements.
3. ___ I agree not to abuse or neglect the adopted animal. If P.A.W.S. Determines the animal has been abused or neglected, I authorize them to remove the animal from my premises without process of law. Adopter agrees to waive all claims for trespass or damage.
4. ___ I agree to provide the adopted animal with necessary vaccinations as advised by my Veterinarian. I will obtain immediate veterinary care if the animal becomes ill or injured.
5. ___ I understand that P.A.W.S. cannot guarantee the health, temperament or training of the adopted animal, and hereby release P.A.W.S. from any claim, cause of action or liability for any injury or damage to persons or property once the animal is in my possession
6. ___ I agree to obtain all licenses required by the local government and to keep an identification tag attached to a properly fitted collar on the adopted animal.
7. ___ If the adopted animal has behavioral problems, I agree to contact P.A.W.S., or a trainer or behaviorist.
8. ___ If adopting a cat, I agree not to declaw it.
9. ___ I agree that if P.A.W.S. determines that any of these provisions of this agreement have not been fully complied with, I will return the animal to P.A.W.S. upon demand. If I fail to return the animal, P.A.W.S. shall have the right, without further notice or demand to enter the premises where the animal may be , and remove the animal without process of law. Adopter agrees to waive all claims for trespass or damage.

RETURN POLICY: I understand that if I cannot keep the animal I am adopting for its lifetime, I agree to contact P.A.W.S. to discuss options. If the animal needs to be returned to P.A.W.S. it will be at my expense. I will not euthanize this animal (unless advised by my Veterinarian for medical reasons) without speaking to P.A.W.S.
